# Section 1 - Journal of Proceedings

At 9:00am, Chair of Dispatch of Business, the Rev. Wes Sedlacek started the day's proceedings with a brief tutorial for today's meeting being held on Zoom.

#### **Resolutions of Policy**

Bishop Hanley introduced the Rev. Wes Sedlacek from the Committee on Resolutions of Policy who introduced Resolution I: A Resolutions that Mandates Anti-Racism and Racial Reconciliation Training for the House of Deputies. It's author, Mr. Alan Murray, Trinity Cathedral, Portland moved to accept a substitute resolution. The motion to substitute the original resolutions was seconded. Mr. Murray spoke to the substituted resolution before a poll was taknen to consider this resolutions. Passed. The Rev. Caroline Litzenberger, St. Michael & All Angels, Portland,

offered an amendment: to change date in second paragraph from Jan 1, 2021 to Jan 1, 2022. Mr. Murray than advised the committee had changed this technical error while meeting earlier this morning. There were no objections to this technical correction. The substituted resolution was approved. (See Appendix)

The Rev. Wes Sedlacek then presented Resolution II: A Resolutions to Study the Complicity of the Diocese of Oregon in Oppressive Acts of Racism and Exclusion, submitted by Mr. Alan Murray. Wes Sedlacek then called on Mr. Murray to offer and discuss a substitute resolution. The motion was called to consider the substitute resolution and approved. Mr. Murray than spoke to the substitute resolution. The vote was called and the substituted resolution passed. (See Appendix)

# Treasurer's Report

Bishop Hanley introduced Mr. Rick Grimshaw, Treasurer of the Board of Trustees, to provide the report of the Board of Trustees and the Investment Committee Report. In addition to a bullet Powerpoint presentation, Mr. Grimshaw advised that pursuant to Oregon Law, the Board of Trustees approved a potential loan to our new bishop to assist her in the purchase of a home within our Diocese, with a principal value not to exceed \$150,000, a maxiumum 3-year term, and an interest rate of 2%.

# **Budget Report**

Bishop Hanley called on Mr. Don Metheny to present the Budget Report. Mr. Metheny discussed the two budgets previously posted on the Convention website: the 2021 Proposed Budget approved by Council on September 26, 2020, and the 2021 Revised Budget prepared by the Diocesan Controller and the Budget Committee chair earlier in October, after the Standing Committee saw the need for an increase to the Bishop's compensation that better reflected the standards for a diocese of our size. After further discussion, Mr. Metheny moved to adopt the revised program budget. The revised budget was approved. (See Appendix)

# Registrar Section 2 – Lay Delegates to Convention

Article IV, Sec. 5 of the Constitution, cites authority for the number of Delegates that each congregation is entitled to send to Convention.

Sec. 5. Lay members shall consist of Delegates from Parishes and Missions as provided in this section. The number of Lay Delegates to Convention for each Parish and Organized Mission in union with the Convention, and with written approval of the Bishop, from each Parochial Mission shall be according to the following schedule:

<sup>\*</sup>Pledging Units are families or individuals — who are not members of another pledging family within the Parish or Mission, who have made written pledges for the year in which the selection of Delegates takes place.

Sec. 7. (b) Notwithstanding subsection (a). duly elected or appointed Lay members of Board of Trustees, Standing Committee, and Diocesan Counsel shall have all rights, including the right to vote, at annual Conventions.

# Section 6 – Diocesan Institutions

The legal corporate title through which the business pertaining to the Church and its charities is transacted, is set forth here for the convenience of those contemplating gifts, devises, or grants of real estate.

#### THE DIOCESE OF OREGON

The Church in this Diocese is incorporated under the name of the Diocese of Oregon, 11800 S. Military Lane, Portland, Oregon 97219. The corporation holds in trust all property given for objects connected with the Church in this Diocese other than property held by parochial or other corporations. The Bishop, the Officers and Board of Trustees, elected by the Diocesan Convention, administer the funds.

#### LEGACY GOOD SAMARITAN HOSPITAL AND MEDICAL CENTER

A part of the Legacy Health System, this nonprofit corporation controls, manages and operates Legacy Good Samaritan Hospital and Medical Center, 1015 NW 22nd Avenue, Portland, Oregon 97210. The Bishop and one Director, elected by Diocesan Convention, serve on the Legacy Health Systems Board of Directors.

# **GOOD SAMARITAN HOSPITAL CORVALLIS**

This nonprofit corporation controls, manages and operates the Good Samaritan Hospital Corvallis. The Bishop is the Chairman of the Board of Directors and appoints two additional Board members.

#### **SAMARITAN VILLAGE**

This nonprofit corporation controls, manages and operates Samaritan Village, 285 NW 35th Street, Corvallis, Oregon 97330, the retirement facility sponsored by the Diocese of Oregon. This facility has been in operation since September 1, 1962 and continues to operate at full capacity, with a short waiting list. The Bishop is President of the Board of Trustees.

#### **OREGON EPISCOPAL SCHOOL**

This nonprofit corporation controls, manages, and operates Oregon Episcopal Schools, a school for boys and girls, formerly known as St. Helen's Hall and Bishop Dagwell Hall, at 6300 SW Nicol Road, Portland, Oregon 97223. The Bishop serves as Chairman of the Board and Episcopal Trustees serve three-year terms in a rotation basis.

#### CENTER FOR COMMUNITY COUNSELING

This nonprofit corporation controls, manages, and operates the Center for Community Counseling, 1465 Coburg Road, Eugene Oregon 97401, a counseling agency. The Bishop appoints one member of the Board of Directors.

# Section 9- Appendix Bishop-Elect Akiyama Convention Sermon

#### 2020 Convention Sermon

Bishop-Elect Diana's Sermon:

Thank you to Bishop Hanley who has generously invited me to preach at his last diocesan convention. It is an unusually generous offer and I want to thank you, Bishop Hanley, for inviting me to join you all this morning.

As happens to most of us at some time or another, you are walking in a public space - maybe it's at the mall, or along the side of a road, or in a park, or on your favorite walking trail, and you see someone coming toward you, so you smile warmly. Maybe you say hello, or maybe you just smile and wave, and they return your gesture with a stern look, or a glare, or an intentional look like "I don't see you", and they keep walking past you. And there it is. You're left with that momentary feeling of hurt, emptiness, and then maybe, typically, anger. You think, "I was being nice, I was being friendly. What is wrong with that person?" And then you decide, "You know what? That was stupid of me to smile. I'm never going to smile again to anyone walking toward me. Because people just are rude, and I don't want to feel hurt like that again."

Whatever house you enter, first say, peace to this house. And if anyone is there who shares in peace, your peace will rest with that person. But, if not, it will return to you.

How does unreceived peace return to us? This is an important question because the instruction has an assumption embedded into it. There is an assumed wisdom here about how unreceived peace returns to us.

How does unreceived peace return to us in these times we are in? The stress feels incredibly high. We have stress on the national level. We have stress at the local level where protests, threats of violence, hostility between people who are at odds with each other seem to threaten our sense of stability and peace. We have the stress of this pandemic as it weighs on us and wears us down. How does unreturned peace come back to us in these times? We are only days away from the national election, which will be historic either way it turns out. Accompanying the election are fears of riots, violence and more unrest.

What are we, the church, called to *do* at this time? What are we called to *be* in this time? If Jesus' instructions, about peace that has been not received, could speak to us today, what would it look like? And even more, what would it require of us?

Offering peace, is an offer of openness. When we wish one another peace, our hands are open as a sign of open hearts. The only way we can offer peace is to be open. But all it takes is a smackdown, a refusal, a sneer or worse to make us regret being open. And that is what Jesus is instructing us about. It is why he is making this assurance: that your peace, if it's unreceived, will come back to you.

How does that work? It is hard to figure that out, especially if you have ever been through that kind of experience where your warmth, your openness, your peace, was not received, and was, in fact, met with hostility. If you struggled through that discomfort and come through it, perhaps it's because you know a little bit about the work involved in finding that spiritual center, so that your peace does return to you. If so, you also know that the spiritual practice is to not allow destruction or hostility to harden your heart.

There is really only one way that peace refused can come back to us, and that's by embracing vulnerability. It's by moving into that same peace that you just offered. This is at the heart of non-violence. It is the *core* of non-violence.

If someone refuses the peace we offer, it returns to us because we continue to offer it. We do not withdraw. We do not strike out. We do not try to even some score because we feel hurt or angry. And Jesus knows this. He knows vulnerability is the key. Not because he is testing us, but because he knows we do not yet trust the vulnerability that this requires—to find the spiritual center that is stronger than force and fear.

So, knowing this, Jesus instructs the seventy to go out to the villages, to the towns, with nothing. He essential-

ly says, "Go. Be vulnerable." Be needful of the hospitality and the compassion of strangers. Be needful of the compassion and generosity of the other. And through this vulnerability, he knew that they would come to learn the deeper truth of what it means to follow him...what it looks like to forgive...what it looks like to love...what it looks like to be reconciled. He knows what it means to offer peace, to be rejected and to not respond with hostility or retraction. In short, what it means to follow Jesus is to be transformed into a servant leader, rather than a leader who lords over all.

For too long the church has enjoyed a kind of "lording over" position. In the form of, "We've got it all figured out, y'all come over here." The church has been a bit like the cool kids on the playground. People want to come to us, to be with us. We're too cool to go find out what might be going on over there. And I know this narrative because despite my criticism of the Church over the years, I've been proud to be an Episcopalian; never wanted to be anything else. I even wondered why more people don't come our way.

So this passage from Luke's gospel today, drew me into a long protracted reflection on what is required to have our peace returned to us if it's refused.

What is the church called to do in this instance? How are we called to respond? How do our fears and our hurts shape us in ways that are not helpful? We know that fears are never the answer; it is never the way to travel if we are seeking reconciliation and healing. But how do we get to this place of having peace returned if we're faced with refusal, or worse. Allowing fear to shape our behavior, being defensive, striking out, may seem easier. But the truth is there is no easy or comfortable way to follow Jesus, to offer peace. And so we are called to remain open and vulnerable if we are really, truly, authentically to offer peace to others.

Now, will we be hurt? Yeah. But avoiding hurt is not our calling. We are not called to be safe. We are not called to be secure if it means not extending peace to the other. We are called to be with others, to be vulnerable with them, rather than to have power over them. We are called to be servants who desire healing and who can adapt when hostility confronts us. Who can adapt, not by being forceful with rejection, but by being open even so and offering ourselves even as it requires us to vulnerable in the face of hostility.

Peace is not a weapon that we use to subdue an opponent. Peace is a means by which we connect with others in order to put down pretense, in order to put down fear, and to let others into our hearts. Peace is, at its core, healing and wholeness. It is about the beloved community alive and vibrant and loving that reflects all that we have learned as we follow Jesus.

We need peace now, perhaps more than ever, or perhaps as we always have needed it. Let us be bravely vulnerable as we offer our peace to others. And let our peace return to us, as a reflection of our spiritual work. To continue to lean into that peace, even if it is rejected, even if it is met with hostility. Let us remain steadfast lovers of Jesus, the ultimate peacemaker, who was vulnerable beyond vulnerable on that cross. And who, by doing so, showed us a new way forward.

Peace be with you.

# RESOLUTIONS REFERRED TO DIOCESES FROM THE 79TH GENERAL CONVENTION

#### **Proposed Constitutional Amendments, First Reading**

The following Constitutional amendments shall be read by the Secretary of the Diocesan Convention preceding the final vote at the 80<sup>th</sup> General Convention in 2021, such reading to be certified by the Diocesan Convention with the Secretary of the General Convention.

#### Ao63: Amend Article X of the Constitution of the Episcopal Church (First Reading)

Resolved, That the 79th General Convention of The Episcopal Church amend Article X of the Constitution of the Episcopal Church as follows

#### **ARTICLE X**

The Book of Common Prayer, as now established or hereafter amended by the authority of this Church, shall be in use in all the Dioceses of this Church. No alteration thereof or addition thereto shall be made unless the same shall be first proposed in one regular meeting of the General Convention and by a resolve thereof be sent within six months to the Secretary of the Convention of every Diocese, to be made known to the Diocesan Convention at its next meeting, and be adopted by the General Convention at its next succeeding regular meeting by a majority of all Bishops, excluding retired Bishops not present, of the whole number of Bishops entitled to vote in the House of Bishops, and by a vote by orders in the House of Deputies in accordance with Article I, Sec. 5, except that concurrence by the orders shall require the affirmative vote in each order by a majority of the Dioceses entitled to representation in the House of Deputies. But notwithstanding

anything herein above contained, the General Convention may at any one meeting, by a majority of the whole number of the Bishops entitled to vote in the House of Bishops, and by a majority of the Clerical and Lay Deputies of all the Dioceses entitled to representation in the House of Deputies, voting by orders as previously set forth in this Article:

- (a) Amend the Table of Lessons and all Tables and Rubrics relating to the Psalms.
- (b) Authorize for trial use throughout this Church, as an alternative at any time or times to the established Book of Common Prayer or to any section or Office thereof, a proposed revision of the whole Book or of any portion thereof, duly undertaken by the General Convention.
- (c) Authorize for use throughout this Church, as provided by Canon, alternative and additional liturgies to supplement those provided in the Book of Common Prayer.

And Provided that nothing in this Article shall be construed as restricting the authority of the Bishops of this Church to take such order as may be permitted by the Rubrics of the Book of Common Prayer or by the Canons of the General Convention for the use of special forms of worship.

# A089: Amend Articles VI and VIII Regarding Full Communion

Resolved, That the 79th General Convention amend Articles VI and VIII to read as follows:

#### ARTICLE VI

Sec. 1. The House of Bishops may establish a Mission in any area not included within the boundaries of any Diocese of this Church or of any Church in *full* communion with this Church, and elect or appoint a Bishop therefor.

#### **ARTICLE VIII**

No person shall be ordered Priest or Deacon to minister in this Church until the person shall have been examined by the Bishop and two (2) Priests and shall have exhibited such testimonials and other requisites as the Canons in that case provided may direct. No person shall be ordained and consecrated Bishop, or ordered Priest or Deacon to minister in this Church, unless at the time, in the presence of the ordaining Bishop or Bishops, the person shall subscribe and make the following declaration:

I do believe the Holy Scriptures of the Old and New Testaments to be the Word of God, and to contain all things necessary to salvation; and I do solemnly engage to conform to the Doctrine, Discipline, and Worship of the Episcopal Church.

Provided, however, that any person consecrated a Bishop to minister in any Diocese of an autonomous Church or Province of a Church in *full* communion with this Church may, instead of the foregoing declaration, make the promises of Conformity required by the Church in which the Bishop is to minister.

If any Bishop ordains a Priest or Deacon to minister elsewhere than in this Church, or confers ordination as Priest or Deacon upon a Christian minister who has not received Episcopal Ordination, the Bishop shall do so only in accordance with such provisions as shall be set forth in the Canons of this Church.

No person ordained by a foreign Bishop, or by a Bishop not in *full* communion with this Church, shall be permitted to officiate as a Minister of this Church until the person shall have complied with the Canon or Canons in that case provided and also shall have subscribed the aforesaid declaration.

A Bishop may permit an ordained minister in good standing in a church with which this Church is in *full* communion as specified by the Canons who has made the foregoing declaration, or a minister ordained in the Evangelical Lutheran Church in America or its predecessor bodies who has made the promise of conformity required by that Church in place of the foregoing declaration to officiate on a temporary basis as an ordained minister of this church. No minister of such a Church ordained by other than a Bishop, apart from any such ministers designated as part of the Covenant or Instrument by which full communion was established, shall be eligible to officiate under this Article.

#### A122: Amend Article IX to Change Removal to Admonition

Resolved, That the Article IX of the Constitution be amended as follows:

#### ARTICLE IX

The General Convention may, by Canon, establish one or more Courts for the Trial of Bishops.

Presbyters and Deacons canonically resident in a Diocese shall be tried by a Court instituted by the Convention thereof; Presbyters and Deacons canonically resident in a Missionary Diocese shall be tried according to Canons adopted by the Bishop and Convocation thereof, with the approval of the House of Bishops; provided that the General Convention in each case may prescribe by Canon for a change of venue.

The General Convention, in like manner, may establish or may provide for the establishment of Courts of Review of the determination of diocesan or other trial Courts

The Court for the review of the determination of the trial Court, on the trial of a Bishop, shall be composed of Bishops only.

The General Convention, in like manner, may establish an ultimate Court of Appeal, solely for the review of the determination of any Court of Review on questions of Doctrine, Faith, or Worship.

None but a Bishop shall pronounce sentence of *admonition*, or suspension, <del>or removal</del> or deposition from the Ministry, on any Bishop, Presbyter, or Deacon; and none but a Bishop shall admonish any Bishop, Presbyter, or Deacon.

A sentence of suspension shall specify on what terms or conditions and at what time the suspension shall cease. A sentence of suspension may be remitted in such manner as may be provided by Canon.

#### A150: Amend Article 1.2 of the Constitution

Resolved, That Article I, Section 2 of the Constitution is hereby amended to read as follows:

#### Article I

Sec. 2. Each Bishop of this Church having jurisdiction, every Bishop Coadjutor, every Bishop Suffragan Bishop, every Assistant Bishop, and every Bishop who by reason of advanced age or bodily infirmity, or who, under an election to an office created by the General Convention, or for reasons of mission strategy determined by action of the General Convention or the House of Bishops, has resigned a jurisdiction, shall have a seat and a vote in the House of Bishops. A majority of all Bishops entitled to vote, exclusive of Bishops who have resigned their jurisdiction or positions, shall be necessary to constitute a quorum for the transaction of business. Bishops who exercise or have jurisdiction are those who exercise ecclesiastical authority in a diocese or other jurisdiction of this Church.

#### A151: Amend Article II.4-8 of the Constitution

Resolved, That Article II.4-8 of the Constitution is hereby amended to read as follows:

#### ARTICLE II

Sec. 4. It shall be lawful for a Diocese, at the request of the Bishop of that Diocese, to elect not more than two Suffragan. Bishops Suffragan, without right of succession, and with seat

and vote in the House of Bishops. A Suffragan-Bishop Suffragan shall be consecrated and hold office under such conditions and limitations other than those provided in this Article as may be provided by Canons of the General Convention. A Suffragan-Bishop Suffragan shall be eligible for election as Bishop Diocesan or Bishop Coadjutor of a Diocese, or as a Bishop Suffragan in another Diocese.

Sec. 5. It shall be lawful for a Diocese to prescribe by the Constitution and Canons of such Diocese that upon the death, removal or deposition of the Bishop or if the Bishop resigns, or is removed from office pursuant to Canon III.12.12(7), a Suffragan Bishop Suffragan of that Diocese may be placed in charge of such Diocese and become temporarily the Ecclesiastical Authority thereof serving as the Bishop Diocesan Pro Tempore-until such time as a new Bishop shall be chosen and consecrated; or that during the disability or absence of the Bishop, a Bishop Suffragan of that Diocese may be placed in charge of such diocese and become temporarily the Ecclesiastical Authority thereof serving as the Bishop Diocesan Pro Tempore of the Diocese.

Sec. 6. A Bishop may not resign jurisdiction without the consent of the House of Bishops.

Sec. 7. It shall be lawful for the House of Bishops to elect a Suffragan-Bishop Suffragan who, under the direction of the Presiding Bishop, shall be in charge of the work of those chaplains in the Armed Forces of the United States, Veterans' Administration Medical Centers, and Federal Correctional Institutions who are ordained Ministers of this Church. The Suffragan Bishop Suffragan so elected shall be consecrated and hold office under such conditions and limitations other than those provided in this Article as may be provided by Canons of the General Convention. The Suffragan-Bishop Suffragan shall be eligible for election as Bishop Diocesan, orBishop Coadjutor or Suffragan-Bishop Suffragan of a Diocese.

Sec. 8. A Bishop Diocesan or Coadjutor who has for at least five years next preceding exercised jurisdiction as the Ordinary, served as the Bishop Diocesan or as the Bishop Coadjutor, of a Diocese for any period of time, may be elected as Bishop Diocesan, Bishop Coadjutor, or Suffragan—Bishop Suffragan of another Diocese only if five or more years have passed since the Bishop first served as Bishop Diocesan or Bishop Coadjutor of the Diocese in which the Bishop is currently or last served as Bishop Diocesan or Bishop Coadjutor. Before acceptance of such election a resignation of jurisdiction in the Diocese in which the Bishop is then serving, conditioned on the required consents of the Bishops and Standing Committees of the Church to such election, shall be submitted to the House of Bishops, and also, if the Bishop be a Bishop Coadjutor, a renunciation of the right of succession. Such resignation, and renunciation of the right of succession in the case of a Bishop Coadjutor, shall require the consent of the House of Bishops.

#### A152: Amend Article III of the Constitution

Resolved, That Article III of the Constitution is hereby amended to read as follows:

#### ARTICLE III

Bishops may be consecrated for foreign lands upon due application therefrom, with the approbation of a majority of the Bishops of this Church entitled to vote in the House of Bishops, certified to the Presiding Bishop; under such conditions as may be prescribed by Canons of the General Convention. Bishops so consecrated shall not be eligible to the office of Diocesan or of Bishop Coadjutor of any Diocese in the United States or be entitled to vote in the House of Bishops, nor shall they perform any act of the episcopal office in any Diocese or Missionary Diocese of this Church, unless requested so to do by the Ecclesiastical Authority thereof. If a Bishop so consecrated shall be subsequently duly elected as a Bishop of a Missionary Diocese of this Church, such election shall then confer all the rights and privileges given in the Canon Canons to such Bishops.

#### A153: Amend Article IV of the Constitution

Resolved, That Article IV of the Constitution is hereby amended to read as follows:

#### **ARTICLE IV**

In every Diocese a Standing Committee shall be elected by the Convention thereof, except that provision for filling vacancies between meetings of the Convention may be prescribed by the Canons of the respective Dioceses. When there is a Bishop in charge of the Diocese, the Standing Committee shall be the Bishop's Council of Advice. If there be no Bishop or Bishop Coadjutor or Bishop Suffragan Bishop canonically authorized to act, the Standing Committee shall be the Ecclesiastical Authority of the Diocese for all purposes declared by the General Convention. The rights and duties of the Standing Committee, except as provided in the Constitution and Canons of the General Convention, may be prescribed by the Canons of the respective Dioceses.

# A176: Amend Article V - Second Reading

(Note: this is actually a first reading, because there was a floor amendment in 2018 and therefore must be read again in 2021)

Resolved, That Article V, Section 1 is amended as follows:

Sec. 1 A new Diocese may be formed, with the consent of the General Convention and under such conditions as the General Convention shall prescribe by General Canon or Canons, (1) by the division of an existing Diocese; (2) by the junction of two or more Dioceses or of parts of two or more Dioceses; or (3) by the erection into a Diocese of an unorganized area evangelized as provided in Article VI. The proceedings shall originate in a Convocation of the Clergy and Laity of the unorganized area called by the Ecclesiastical Authority-Bishop for that purpose; or, with the approval of the Ecclesiastical Authority, in the Convention of the Diocese to be divided; or (when it is proposed to form a new Diocese by the junction of two or more existing Dioceses or of parts of two or more Dioceses) by mutual agreement of the Conventions of the Dioceses concerned, with the approval of the Ecclesiastical Authority of each Diocese. After consent of the General Convention, when a certified copy of the duly adopted Constitution of the new Diocese, including an unqualified accession to the Constitution and Canons of this Church, shall have been filed with the Secretary of the General Convention and approved by the Executive Council of this Church, such new Diocese shall thereupon be in union with the General Convention.

# A183: Amend Article IX - First Reading

Resolved, That the Constitution Article IX be amended to read as follows:

Article IX

The General Convention may, by Canon, establish one or more Courts for the Trial of Bishops.

Presbyters and Deacons <del>canonically resident in a Diocese</del>-shall be tried by a Court instituted by the *General* Convention by Canon. <del>thereof;</del>. <del>Presbyters and Deacons canonically resident in a Missionary Diocese shall be tried according to Canons adopted by the Bishop and Convocation thereof, with the approval of the House of Bishops; provided that the General Convention in each case may prescribe by Canon for a change of venue.</del>

The General Convention, in like manner, may establish or may provide for the establishment of Courts of Review of the determination of diocesan or other trial Courts.

A sentence of suspension shall specify on what terms or conditions and at what time the suspension shall cease. A sentence of suspension may be remitted in such manner as may be provided by Canon.

# Section 9– Appendix Bishop Hanley's Convention Address

# Good morning!

It is good to be with you one more time for diocesan convention. This is, of course, not the form of diocesan convention I imagined holding last year. But it is the convention that this time and space offers us. When I began as your bishop, I talked a great bit about the Camino de Santiago, the 500-mile walk across Spain to the shrine of the bones of St. James. I suspect, for some folks, I talked a little bit too much about it. But here at the end of my time as your bishop, I am going to talk one more time about the Camino and the good news this is the last time I will do so, so please bear with me.

There was a day on the walk that I was walking alone. My traveling companion had chosen to walk differently than I, and we were going to meet up again in a few days. The day had dawned gray and cloudy, and by the time I had gotten my pack on it had started to rain. I walked in the rain for a couple of minutes and then I decided to stop at a coffee shop for breakfast. I ordered coffee con leche and sipped it slowly, waiting for the rain to stop. The rain continued so I order another coffee. I waited again for the rain to stop. The rain continued and I ordered a third cup of coffee. And the rain continued.

Finally, I knew there was nothing for it but to get out there and walk in the rain. About a mile into my walk, I found myself walking by a stranger. She was from England, and as we began to talk and walk in the rain, (did I mention that it was still raining?) we spoke as strangers do. Where are you from? What do you do for a living? What interests do you have? At some point, we discovered that we had something in common. We were both storytellers.

She was a professional, and I was an amateur. And so we began to tell each other tales, tales we knew. Often, her tales, were ones that I have never heard before. And at other times, I would tell one of those tales, and she would occasionally say something like, "Oh, I've not heard that version of that story you're telling."

The real highlight of that day came in that conversation with me was when she said to me that she had never heard the story I was telling. Be that as it may, something wonderful happened to us that day as we journeyed together and told tales. The rain (remember the rain?) seemed to disappear, even though it continued. And the sad face, and the struggle to continue, turned into joy in the walking.

We arrived at our journey's end very wet, but satisfied with the day's travel.

I tell you this story because this year of 2020 seems like one very long and wet walk, even for an Oregonian who might love the rain.

One of the things that has happened is we've been struggling with Covid. Another is the hyper-sensitive politics. And the wildfires, on top of whatever medical or person struggles that we're already dealing with. And when it rains, I remember the story and I look for someone to talk to. The journey is always easier when you share it.

If you're wondering how the theme of this convention was chosen this year, look no further, I chose it. One word, Beloved. I chose it for two reasons. First, because it reminds me of the church-wide efforts now underway to create a beloved community. Part of this work centers around engaging the way of love; practices for a Jesus-centered life. This is a curriculum created by The Episcopal Church in which

participants are invited to learn how to turn, learn, pray, worship, bless, go and rest. It's an intentional commitment to a set of practices that will lead to a life in the beloved community. The other part of becoming beloved community centers around our need to tell the truth at this time around white supremacy and racial oppression. Our need to stand for justice as our systems and to be a ---- for healing by breaking free of white supremacy with training, formation, and action.

These church-wide efforts are critical, and more information about them can be found on the national church's website.

The second reason I chose this title for our convention is more personal. What I want you all to know as I retire as your bishop is that you are beloved by God.

Near the end of the bible there are three short letters known as the Johannine Epistles. The first one does not read much like a letter; more like a word to the church. It was written in opposition to certain beliefs that had risen in the community which were not deemed orthodox. Those who had gone out into the community were teaching that Jesus was a pure spirit, and not a human being at all. This, the writer proclaims, is not the truth. Toward the end of that epistle, the author says these words: "Beloved, let us love one another because love is from God. Everyone who loves is born of God and knows God. You, my friends, are beloved of God.

In the days ahead, we will be tempted to set ourselves in opposition to others as we encounter the results of our national election. Some Episcopalians will be pleased by the results of that elections and others will not be. Whatever it might be, as for me, this what I pledge—and the text of this pledge I am going to share is from the website Greater Angels. And from a movement inside that website called Malice Toward None.

This is what I pledge: Regardless of how the election turns out, I will not hold hate, disdain, or ridicule for those who voted differently from me. Whether I am pleased or upset with the outcome, I will seek to understand the concerns and aspirations of those who voted differently and will seek opportunities to work with people with whom I disagree. I invite your consideration of a similar pledge.

You are beloved of God. I pray we never forget the simple truth that we live much of our lives out of a sense of our beloved status.

As I get ready to step down as your bishop and hand my crosier to Bishop-elect Diana Akiyama, I am please that we are where we are as a diocese. Not that everything is perfect; or that there will not be much for the new bishop to do, but just that we have made progress in several areas in the last ten years. When I arrived in the diocese, it was after several years of strife concerning the role and function of the bishop, and the very short episcopacy of Johncy Itty. While a good start in healing had begun in the years that Sandy Hampton served the diocese so well, there were still scars to heal to continue the healing and rebuilding, and there was rebuilding work to be done.

So the diocesan staff and leaders bodies of the diocese worked together to move us forward in mission and ministry. Diocesan roles and responsibilities were clarified, and work began on a mission plan for the diocese. This plan centered on four keys areas of diocesan life: congregations, diocesan-wide

mission, leadership development and gospel justice. Much of what we have been about these last 10 years can be discussed under one of these key areas.

Today I believe we have many strong and vital congregations, strong leaders on the board and commissions of the diocese, and we have an excellent diocesan staff. I am especially proud of the good work that has continued and continues to happen within our Latino community and the continued building up of our capacity to offer the Episcopal branch of the Jesus movement to our Latino brothers and sisters. Thank you especially to Beto Arciniega for your good work all these years.

While many challenges remain, we have the capacity to move forward in mission together. And I commend the work ahead to your care and prayer. In the past year we have done some wonderful work together. First, a shout out to all the clergy and lay leaders of congregations who have found a way to continue in ministry through and during Covid-19. Second, a shout-out to those working in specialized ministries, particularly those working as chaplains in hospitals, care facilities, and with the police and firemen of the state. Finally, a shout out to the lay volunteers and non-stipendiary clergy of the diocese for all the ways in which you have adapted to this new world we are living in.

In addition to these shout outs, let me tell you about a few projects completed this year that I believe to be of help to the diocese as we move forward. First, we almost sold the diocesan offices. Yes, it's true, in the end we continue to be in the building, and we do not have a signed contract for sale. Yet, we have become clear that the work of moving the diocesan offices needs to continue into the future.

Second, a forensic audit was conducted by the Board of Trustees to ensure the financial position of the diocese. Third, The Corporation Sole of the diocese, which began in the first days of the diocese but has become an antiquated entity, has been dissolved. The board of EBOF has given out emergency grants to assist congregations as they sought to upgrade their capacity for on-line worship. And fifth, the diocesan leadership has made a strong financial commitment to the neighborhood of Portland and to the work of St. Philip the Deacon Episcopal Church—the church that has identified itself as a traditionally African American congregation. This commitment is for funding congregational leadership and mission as they enter a conversation in that neighborhood for affordable housing. For more information on this project, talk to St. Philip's clergy and lay leaders.

All the work that I have just described was undertaken in the midst of a pandemic; and taken while all the regular work of the diocesan office continued, such as being paymaster to most of our congregations, assisting congregation with clergy transitions and serving many other congregational needs as well.

In the past ten years I have the pleasure of working with many wonderful people on the diocesan staff, on the boards and commissions of the diocese, and in the congregations. I could not name everyone if I tried, and so I am not going to try. Only to say thank you for the gift of your friendship and love, As we have attempted to live to the best of our ability to live and walk in the way of love in the Diocese of Oregon. You are beloved of God, and you have been a blessing to me. It is not the role, I believe, of the out-going bishop to chart the course for the future, or to try to set out a plan of action for the years to come. That work is best left to the lay and ordained leaders who continue into the future. But it is my

role to wish you well in the journey ahead, and to hold you everyone of you in my thoughts and my prayers.

In a few short months, I will be retired. Marla and I intend to remain in Oregon, and in Portland as we have a wonderful, little new granddaughter to help raise. We are both extremely grateful the opportunity to come and live and work in Oregon in these past years.

I always thought I would end up in the Pacific Northwest. I just thought, prior to my election as bishop, I would just have to wait until retirement to make that move. Your willingness to walk with me in mission and ministry these past years had made a world of difference in my life and in my wife's. And we are forever grateful to you.

Let me close with one more story. This story does not come from the Camino, but from a trip Marla and I took to England with our with our daughters when they were in their teen years. On arrival, we met Marla's big brother Gary and his sister Sheila, and together we rented a British narrow boat for a week. The boat was seven feet wide and 70 feet long. It was the largest boat we could rent and it was created to be used on the large system of canals in England. The boat slept eight individuals; it had a kitchen and seating area as well, but it did not go fast. It was very easy to walk beside the boat as we took the trip. About halfway into our trip we got to a place on the canals where there was a tunnel ahead of us, and we had to enter the tunnel.

The tunnel was miles long. As we entered, we noticed that the light coming, and still available to us at the entrance was diminishing as we got further into the tunnel. Just before we lost that light entirely, we ran down into the boat and turned on all of the lights. As we continued, the lights in the boat were our only illumination. Also, we noticed that, as we were traveling in a straight line, our eyes made us believe that we were actually turning gradually to one side. Finally, after what seemed like a very long time, we began to see the light at the end of the tunnel, and it slowly grew as we emerged into the English countryside once again. I have been thinking about that experience for some time now as we encounter these days in the United States of America.

To many people from all political sides, this seems like a very dark and dangerous time. It is like, perhaps, we are in a tunnel without light and our eyes are playing tricks on us. This is a time to remember, that the light that will sustain us during this time, is the light we carry with us. It is the light of God; it is the light of the Holy Spirit. It is the light of Christ. It is the light of the church catholic shining forth to carry us forward until we emerge into a brighter future.

I pray this day that you are managing the challenges you face, and with the divine assistance you may continue to be well, that all manner of things may be well.

Blessings to you this day.

#### Section 9- Appendix Resolutions of Policy

## 2020 Anti-Racism Training for Deputies and Alternates (Substitute Resolution – As amended in Committee)

*Resolved*, That this 132rd Convention of the Diocese of Oregon submit the following resolution to the 80th General Convention of The Episcopal Church:

Resolved, the House of \_\_\_\_\_ concurring, That beginning on January 1, 2022 the lay and ordained leadership of The Episcopal Church, including all ordained persons, professional staff, and those elected or appointed to positions of leadership on committees, commissions, agencies, and boards, and as deputies or alternates to General Convention be required to take anti-racism training and receive certification of such training, in accordance with the existing policies of The Episcopal Church, the provinces and the dioceses, and be it further

Resolved, That the Executive Council, through appropriate staff and interim bodies, develop and implement processes for collecting information regarding how this mandate is being implemented and data on the participation in training by covered individuals within their jurisdiction from the dioceses, provinces, Episcopal seminaries and other programs preparing individuals for ordination, committees, commissions, agencies and boards, and all other entities subject to this requirement, and make such information and data readily available to the Church at least 6 months prior to each General Convention.

#### Explanation

At the 73rd General Convention in Denver, <u>Resolution 2000 B049</u> required "lay and ordained leadership of the Episcopal Church, including all ordained persons, professional staff, and those elected or appointed to positions of leadership on committees, commissions, agencies, and boards be required to take anti-racism training and receive certification of such training." It further required "that each diocese select and authorize appropriate programs that will be used at the diocesan and parochial levels" and that "each province and diocese […] determine those lay and clergy leaders who are to take the training".

Deputies and alternates to General Convention were not explicitly included in the resolution's list of leaders, but many dioceses, including Oregon, have since included them in their designation of leaders who must take the training. This resolution would make such training for deputies and alternates the policy across the church.

Since GC 2012, the General Convention's Joint Standing Committee on Nominations has been tracking compliance with the anti-racism training requirement for elected churchwide leadership (Church Pension Fund Trustee, Disciplinary Board for Bishops, Executive Council, General Board of Examining Chaplains, General Theological Seminary Trustee, and the Officers of General Convention). These reports illustrate a trend towards compliance among elected positions from 76% (GC 2012), to 84% (GC 2015), and 85% (GC 2018). However, there has been no comparable organized means of collecting data on the extent of compliance with this

mandate at other levels of the Church, neither data on participation in training nor information on what each entity requires in the way of training.

The General Convention is the governing body of The Episcopal Church, adopting its canons and policies, electing its officers. The bishops are already covered by the 2000 training requirement, as are many members of the House of Deputies due to other positions of leadership they may have. It is important that all the members of the House of Deputies take part in anti-racism training to inform their decision making. Extending the 2000 B029 mandate to explicitly cover Deputies will ensure that the intent of that resolution to cover *all* leaders is met.

The Episcopal Church has long recognized its complicity in racism and its call to self-examination, repentance, and reform. Since 2015, in response to Resolution 2015 C019 - Work for Racial Justice and Reconciliation – it has been building the framework of Recoming Reloved Community. This response to systemic racial injustice enhances the capacity of The Episcopal Church to work in communities to organize and advocate against and work to dismantle systems, policies and practices that reinforce violence and acts that perpetuate the sin of racism. Making sure that every leader is appropriately trained is an important step toward an anti-racist future.

## 2020 Study on the Complicity of "The Diocese of Oregon" in Oppressive Acts of Racism and Exclusion (Substitute Resolution)

Resolved, That the 132<sup>nd</sup> Annual Convention of the Diocese of Oregon directs the Commission to End Racism, in consultation with the Bishop, to establish a Task Force on Truth and Racial Reconciliation to respond to the direction of Resolution A143 of the 2009 General Convention to "gather information in its community on (1) the complicity of The Episcopal Church in the institution of slavery and in the subsequent history of segregation and discrimination, (2) examples of resistance to slavery and discrimination and (3) the economic benefits derived by the Episcopal Church from the transatlantic slave trade and the institution of slavery;" and be it further

Resolved, That the Task Force on Truth and Racial Reconciliation be directed to consult with the Executive Council's Committee on Anti-Racism, the Commission to End Racism in the Diocese of Oregon and any *other* available resources to aid them in doing this work, including historical research that pertains to the Episcopal Church in Oregon and its complicity in supporting exclusion laws, white supremacy, segregation and discrimination; and be it further

*Resolved*, That the Task Force report its progress to the Standing Committee, Diocesan Council and the Commission to End Racism by September 2021 and to the 133<sup>rd</sup> Convention of the Diocese of Oregon, and to each succeeding Convention; and be it further

*Resolved,* That the Commission to End Racism develop and recommend to the 133<sup>rd</sup> Diocesan Convention a comparable program to gather information on the Episcopal Church's participation in 1) the mistreatment of Oregon's indigenous peoples, 2) examples of resistance to such mistreatment and discrimination, and 3) the benefits derived by the Episcopal Church from the displacement of tribes, the breaking of treaty commitments and continued discrimination against indigenous peoples; and be it further

Resolved, That the Commission to End Racism develop comparable programs to gather information on the Episcopal Church's participation in 1) the discrimination against immigrants to Oregon, including those from Asia and Latin America, 2) examples of resistance to such discrimination and mistreatment, and 3) the benefits derived by the Episcopal Church from that discrimination; and be it further

*Resolved*, That the information gathered in each process\_be used as the foundation for truth-telling, confession, apology, forgiveness, repentance and reconciliation; and be it further

Resolved, That the 132nd Annual Convention of the Diocese of Oregon urges the Bishop to name a Day of Repentance in response to each process and on that day to hold a Service of Repentance; and be it further

Resolved, That the Diocese of Oregon allocate \$2,000 from the 2021 Diocesan Budget for the work of the Task Force and urges the Task Force to seek additional funding from extrabudgetary sources.

#### Explanation

The passage of Resolution A123 in 2006, which urged dioceses to research those instances where "they were complicit in or profited from the institution of Transatlantic Slavery," has inspired many dioceses to respond to this call to action. This resolution was then extended in Resolution A143 in 2009 and continued to encourage dioceses to engage in this work of truth telling. The Presiding Bishop and the President of the House of Deputies have apologized on behalf of The Episcopal Church for its part in the maintenance of slavery. In order to have reconciliation, there is a need for truth telling. As the Diocese of Oregon did not initially respond to this effort, this resolution is asking the Diocese of Oregon to appoint a Task Force to undertake this work. In Oregon's context, slavery may not be the main focus but it is imperative to understand our original sin of white supremacy extends beyond the Transatlantic Slavery to our State's history of excluding all Black, Indigenous and People of Color (BIPOC).

# Diocese of Oregon Proposed Program Budget for 2021

The Proposed Program Budget for 2021 continues to reflect the Strategic Directions in the Diocese of Oregon Mission and Vision Statement. The Diocesan Council Budget Committee began in January 2014 to design and implement a new mission-responsive process for Diocesan program budget proposals. The process requires that requests for Diocesan funding emphasize support of ministries that are working toward being self-sustaining and which demonstrate a broad or growing reach throughout the Diocese.

The members of the Committee recognize that the complexity of this process created demands on those requesting Diocesan support and appreciate the efforts made by missions and ministries to submit proposals in a timely manner. In 2020, this revised process continues to be followed, asking those making budget requests to give primary emphasis to one of the four strategic directions.

#### **Strategic Directions**

Our mission and vision statements speak broadly and compellingly about our identity as a community, an identity that is informed by a prayerful reading of Holy Scripture and the Book of Common Prayer. However, that identity only becomes visible to us and others as it is clarified through the specific and strategic directions that inform our work together:

- Strengthen and Support Congregational Life
- Strengthen and Support Diocesan Capacity for Mission
- Strengthen and Support Missional Leadership
- Strengthen, Support, and Advocate for Gospel Justice

#### **Diocesan Vision Statement**

Gathered in the love of God in Christ and accepting of diversity, the Diocese of Oregon actively nourishes renewal and growth, cares for creation, and values the unique gifts of all as we encourage innovation to meet the needs of the 21st century church. We ground our lives in Anglican worship while connecting ourselves to the wider church and world.

#### **Development of This Year's Proposed Budget**

The development of the 2021 Budget has been challenging due to uncertainties in both income and expenses. While it is relatively easy to predict rising costs; it is more difficult to predict income, especially from DPA. The 2021 budget reflects our current and best estimates.

#### Line by Line Narrative of 2020 Proposed Budget

#### **INCOME**

#### Line 1: Diocesan Program Assessment (DPA) - \$1,805,036

This income line is the chief operational funding source for the ministries of the diocese. The projected DPA reflects the estimated revenue following the Canonical formula, less the anticipated amount of DPA relief granted by Council and projected non-payment by congregations.

#### Line 2: Episcopal Endowment Fund – \$166,000

In the 1880s (shortly after the Diocese of Oregon was established), diocesan leaders established a restricted endowment fund to support the expenses of maintaining a bishop. The compensation and expenses of the Diocesan Bishop are paid first from this endowment fund. At the recommendation of the Standing Committee and the Diocesan Investment Consultant, the Board of Trustees unanimously voted at their September, 2020 meeting to fully fund the agreed upon total compensation package for the 11th Bishop of Oregon from these restricted funds, for both the 2021 and 2022 Program Budget years..

#### Lines 3-5: Interest Income (Deposits, Mission Trust Fund and Platt Bequest) - \$14,544

These are funds received from trusts and bequests for the use of the general program budget.

#### Line 6: Other Income and Transfers – \$32,212

These funds represent the reserves for General Convention from the 2019 and 2020 budgets plus a portion of the expected surplus from the 2020 Budget.

#### Line 7: Subtotal Income – \$2,017,792

Subtotal of income before Episcopal Church Program Commitment and Province VII Program Support.

#### Line 8: Less The Episcopal Church Program Commitment – (\$271,468)


This amount represents our assessment for the common life of The Episcopal Church. It is calculated at 15% of 2019 income above \$140,000. Please note: Since we do not yet have audited numbers for 2019, the actual assessment may change.

#### Line 9: Province VIII Program Support – (\$6,847)

This amount represents our contribution to the expenses of Province VIII, the collection of those Dioceses of the Episcopal Church located in the western states and Taiwan. It is calculated as 0.35% of anticipated income.

#### **CONGREGATIONAL LIFE**

#### Line 12: Education for Ministry – \$2,000

EfM is a theology program delivered as distance education by the School of Theology of the University of the South. Under the guidance of trained mentors, students cover the basics of a theological education in the Old and New Testaments, church history, liturgy, and theology. The Diocese of Oregon is a member, which reduces tuition for participants and offers additional training and support for mentors who lead EfM groups. This line item pays our diocesan membership fee and assists the diocesan coordinator with office expenses and participation in national coordinator Training events.

#### Line 13: Liturgy and Music Commission – \$500

This is a Canonically required Commission. The Commission meets regularly to plan liturgies for Diocesan Convention and Clergy Conference, which bring newer resources to the attention of those attending. The Commission also sponsors liturgical ministry events to encourage members of congregations throughout the Diocese to grow in skill and enthusiasm for worship.

#### Line 14: Ministry in Christian Education & Lifelong Formation – \$1,000

The Diocese would like to be able to send people engaged in or interested in children's ministry to trainings.

#### Line 15: Required Church Trainings – \$700

This line item now includes Diverse Church Training in addition to Safe Church Training. Carol Sedlecek+ coordinates these trainings. Online Safe Church courses are now the primary means of providing Safe Church training in the diocese. The online training is free to individuals and subsidized by Church Pension Group. Online training will be provided.

The Diverse Church Training model of the Episcopal Church is designed to make us all more aware of how society's racist past still haunts us today. The goal of the Diocesan Commission to End Racism is to set us free from the bondage of racism that prevents us from being God's people, to be accomplished through online training sessions.

#### Line 16: Stewardship Commission – \$1,000

This line supports the development of a deeper understanding of what it means to be a steward of God's creation by providing formation opportunities for both clergy and parishioners in the theology of stewardship. It also provides information on effective stewardship programs.

#### Line 17: Youth Ministry Commission – \$12,375

Ministry with youth is a high priority in our diocese and in the Episcopal Church. This budget item includes supplies, lodging and food costs for seven (7) diocesan youth events. This year's budget includes support for a Youth Mission Trip.

#### Line 18: Cursillo Event Space – \$1,900

Cursillo is a clergy-supported lay ministry of the Episcopal Church, designed to promote leadership within the Church. A secondary outcome of this ministry is a renewal and rejuvenation of faith among those who participate. This program relies on Diocesan support to pay the costs of space appropriate for holding this event. The Diocesan Program Budget allocation will go toward costs for a weekend retreat facility for use in 2021; additional funds and scholarship assistance were needed may be provided through increases in registration fees. Ellen Onstad is the co-director and contact for this Commission.

#### Line 19: Congregational Vitality Support - \$5,400

Congregational Vitality uses models from the College of Congregational Development and the skills of Diocesan Consultants to assist congregations in deepening their ministry, mission, and leadership.

#### Line 20: Archdeacon Expenses – \$6,130

The increase in the 2020 request represents funds needed to offset the expense of more than 25 Deacons who serve throughout the Diocese without stipendiary support. The supported events will include two annual Deacon gatherings (Clergy Conference and Diocesan Convention), one overnight retreat for Deacons, quarterly formation day meetings with Postulants, candidates and new Deacons, and participation in an Annual Archdeacon Conference sponsored by The Episcopal Church in the U.S. Support will also offset meals and mileage expenses for meetings by the Archdeacons with aspirants,

postulants, candidates, deacons and rectors. Carter Hawley+ is Archdeacon and Canon for Administration.

#### Line 21: Subtotal Congregational Life - \$31,005

#### **DIOCESE**

#### Line 24: Bishop and Senior Staff Costs – \$497,910

This item includes compensation and benefits as well as travel, cell phone and other expenses directly related to the three Full Time Equivalent (FTE) positions below.

- Bishop 1.0 FTE
- Canon to the Ordinary 1.0 FTE
- Controller 1.0 FTE

#### Line 27: Support Staff Costs – \$389,689

This item includes compensation (salaries, expenses, and benefits) for 4.0 FTE diocesan administrative and finance support staff as follows:

- Canon for Administration, 1.0 FTE
- Assistant to the Canon to the Ordinary, 1.0 FTE
- Payroll and Accounts Payable Administrator, 1.0 FTE
- Staff Accountant, 1.0 FTE

#### Line 28-31: Finance and Administrative Costs – \$191,854

This item includes general operating costs (equipment leases, contracts, printing, travel, maintenance, office supplies, insurances, etc.) for the following administrative areas:

- Diocesan Administrative Services
- Diocesan IT Services
- Diocesan Office at the Bishop's Close Building Expenses
- Finance Department

#### Line 32: Subtotal Finance and Administrative - \$581,543

#### **PROGRAM**

#### Line 35: Diocesan-wide Program Staff – \$137,936

This line represents compensation for diocesan staff whose duties are spread over many diocesan programs. Staff include:

- Director of Communications 1.0 FTE
- Canon for Christian Formation 0.5 FTE\*

#### Line 36: Ministry in Communication – \$29,223

This line includes general operating costs associated with the diocesan Ministry in Communication.

<sup>\*50%</sup> of this position is funded by the Board of Trustees from proceeds of the sale of Triangle Lake.

#### Line 37: line deleted

#### Line 38: Latino Ministry: Program Staff – \$181,207

This line represents compensation for diocesan staff whose duties are dedicated to Latino ministries. Staff include:

- Canon for Latino Ministries, .5 FTE
- East side Latino Missioner, .5 FTE
- West side Latino Missioner, .5 FTE

#### Line 39: Latino Ministry: Commission Expense – \$15,500

This line includes general operating costs associated with conducting Latino ministries.

#### <u>Line 40: Subtotal Diocesan Program</u> - \$363,866

#### Line 41: Subtotal Diocese - \$1,443,315

#### **DIOCESAN MISSION**

#### Line 43: Diocesan Commission and Committee Travel & Expenses - \$900

Most of the expenses in Diocesan activities are borne by the participants or their congregations. This line item will ensure support for the participation in any Diocesan Commission or Committee meeting where other needed support may be lacking.

#### Line 44: Diocesan Convention – \$23,000

To cover expenses for the annual diocesan convention, assuming a Registration Fee will be charged to all participants to offset these expenses to some extent.

#### Lines 45-48: Ministry in Higher Education - \$88,440

Support for ministry in higher education in aggregate is the largest dollar commitment that the Diocese makes to activities outside the Bishop's office.

#### Line 45: Ministry in Higher Education Oregon State University – \$36,340

Ruth Krueger is the OSU Episcopal Chaplain, whose work and enthusiasm have grown the ministry to the point that it will now have official 'student group' status and be able to function more fully on campus. This campus ministry also receives significant support and involvement from the Church of the Good Samaritan.

#### Line 46: Ministry in Higher Ed., Portland Metro Episcopal Campus Ministry – \$0

The chaplaincy position for the Portland State University campus is currently vacant. No funds were requested. The Bishop is working on a mission team.

#### Line 47: Ministry in Higher Education University of Oregon - \$42,300

This ministry located in Eugene near the University of Oregon also serves students at Lane Community College. This is a residential program with as many as five students living in the ECM

House during the school year. Throughout the year a student community of house residents and any others who wish to join them gather for dinner and worship on Thursday evenings followed by a time of study. In addition, ECM has entered the seventh year of operating its food bank and is open to all college students in the greater Eugene/Springfield area. Ryan Baker-Fones, seminarian intern, is the Chaplain.

#### Line 48: Ministry in Higher Education Western Oregon University – \$9,800

Western Compass Campus Ministry in Monmouth is an ecumenical ministry (Episcopal, Methodist, and Presbyterian) operating under the auspices of the Wesley Center (Methodist). The program director is Nicolas Ertsgaard. The ministry is small but growing and offering vital engagement with the community through weekly dinners and outreach projects, especially in the area of suicide prevention. Diocesan support represents 26% of the operating budget.

#### Line 49: Retiree Life Insurance – \$1000

To fund life insurance policies for retiring clergy with 20 or more years of service and retiring Diocesan Lay Staff with 10 or more years of service.

#### Line 50: Retiree Medical Insurance – \$39,000

Retiree health insurance is coverage for those spouses of retired clergy who have not yet reached the age of 65 at the time of the retirement of their clergy spouse. (The clergy spouse must have served 20 years or more within the diocese.) It is also for Diocesan Staff who have at least 10 years of service and retire from the Diocese of Oregon.

#### Line 51: Episcopal Transition (Transfer to Reserve) – \$9,800

Following the election of Bishop Itty in 2003, the treasurer of the Diocese of Oregon requested the establishment of a reserve fund in order to budget prudently for the eventual process of nominating, electing, and transitioning to a new bishop.

#### Line 52: General Convention Deputies – \$30,000

Over three years, a reserve account accrues funds to assist our lay and clergy deputies (four each) and alternate deputies (one lay and one ordained) to attend the General Convention. Expenses include registration, travel, and accommodations. With increasing costs, the amount set aside for deputies was increased most recently in 2010 but is still likely to result in deputies and alternates having out-of-pocket expenses. The General Convention will be held in 2021 and this amount represents using both prior year reserves and budget for this year.

#### Line 53: Episcopal Church Women Triennial – \$2,450

Episcopal Church Women hold a triennial gathering in conjunction with the General Convention. This line item allows for funds to accrue over three years for assisting our ECW representatives who attend the ECW Triennial. The General Convention will be held in 2021 and this amount represents using both prior year reserves and budget for this year.

#### <u>Line 54: Subtotal Diocesan Mission</u> – \$194,590

#### LEADERSHIP DEVELOPMENT

#### Line 56: Diocesan Clergy Events – \$7,200

These events are mandatory for all active clergy serving in the diocese and include the Clergy Conference and Renewal of Vows. Costs to the diocese include use of meeting space, cost of meals, as well as travel and honorarium for a conference leader. The Bishop uses discretionary funds to cover some of these costs.

#### Line 57: Commission on Ministry – Ordained Ministry – \$3,500

The commission on ministry for ordained ministry provides guidance and education in ministry for those persons discerning a call to ordained ministry and advises the Bishop on whether individuals are called to ordained ministry. To this end, this commission sponsors and conducts the Diocesan Vocations Conference.

#### Line 58: Commission on Ministry – Baptismal Ministry – \$350

The commission on ministry for baptismal ministry provides guidance and education in ministry formation for lay persons. These offerings are in response to needs of parishes and persons within the diocese, as well as canonical mandates and include an initiative for Discernment Committee Training.

#### Line 59: Fresh Start for Clergy and Congregations – \$7,500

Fresh Start is a two-year program for clergy who are newly called to their present ministry in the diocese, and for lay leaders in the congregations they serve. It helps with issues arising during periods of transition in ministry.

#### Line 60: Academy for Formation and Mission – \$18,800

The Academy strengthens and supports congregational life by providing a variety of types of education for ministry. These include Field Education, preaching for both people preparing for ordination and for lay ministers, a Clinical Pastoral Education Program in collaboration with Legacy/Good Sam, and diaconal education. The Academy is presently working with the Commission on Ministry to strengthen its organizational structure.

#### Line 61: Congregational Leadership Training (Treasurers & Wardens workshops) - \$2,700

These workshops for congregational officers and leaders are offered around the state to develop skills in financial and governance matters. The budget covers travel and other expenses of the workshops.

#### <u>Line 62: Subtotal Leadership Development</u> – \$40,050

#### **GOSPEL JUSTICE**

#### Line 64: Commission to End Racism - \$2,700

Formerly included only Diverse Church Training which is now included in Required Church Trainings. This commission is being revitalized to do new work in the diocese focused on planning events and workshops that engage the diocese around issues of race and racism.

### **Line 65: Ecumenical and Interfaith Commission** (includes Ecumenical Ministries of Oregon membership) – \$3,700

This line supports diocesan ecumenical activities, including membership and support for Ecumenical Ministries of Oregon, a statewide organization intended to bring together Oregon's diverse faith community, a strongly held value in the Diocese.

#### Line 66: Environmental Commission – \$0

The Commission's mission is to help the churches of the Diocese celebrate the sacredness of God's creation, care for the environment, understand current environmental issues and their impact on the livability of our region and world, and to promote models of ministry that incorporate protection, preservation, and sustainable use of God's creation. No funds were requested.

#### Line 67: Episcopal Relief and Development Coordinator adding Local Disaster - \$1,000

This line item provided for limited office costs and travel reimbursement for the coordinator to represent the ERD throughout the diocese, especially at diocesan convention and other large gatherings, and for developing local disaster preparedness workshops. No request for Diocesan funding was received.

#### Line 68: Global Mission Committee – \$1,000

This committee seeks to share information and connect the diocese to the global mission of the Episcopal Church through the Global Episcopal Mission Network (GEMN) by sending a representative to GEMN-sponsored events. Jim Boston+ serves as chair of this committee.

#### Line 69: Sustainable Development Goals - \$0

Eight Millennium Development Goals were established by the United Nations. Our 2006 diocesan convention approved a resolution, beginning in 2008 and ending with the 2015 Budget year. There have been no expenditures for this Line item since 2016.

#### Line 70: Ministry in Prisons – \$13,750

This ministry is comprised of several semi-independent ministries to specific prisons, jails and halfway houses located in the diocese. The ministry includes providing a pastoral presence, skill building, worship and spiritual development. The ministry also hopes to touch and educate the members of every parish through diocesan media, bulletin inserts, Criminal Justice Sunday, and speakers. Tom English+ serves as coordinator of this Ministry.

#### Line 71: Commission on Poverty and Homelessness Administration – \$1,544

The purpose of the Fund to End Poverty and Homelessness is to support the churches of our diocese in promoting mindfulness of the needs of others through education, action, and support. This line provides financial support for travel, convention tables, and office costs to ensure that one hundred percent of donations to the Fund are disbursed rather than being required for in-house expenses. Jeanne Kaliszewski is the Chair of this Commission.

#### Line 72: Recovery Commission – \$3,000

The Recovery Commission offers resources and support to the congregations in the Diocese of Oregon to support and encourage them to welcome and support people in recovery. Costs reflected in the budget include a resource table at Diocesan Convention, participation in the National Episcopal

Recovery Organization, mailings to churches for Recovery Sunday (established by General Convention), and a diocesan workshop for families of addicted persons. Eleanor Suman and Monica Schneider are Co-chairs of this Commission.

#### Line 73: William Temple House – \$2,700

William Temple House is a counseling and social service agency historically affiliated with the Episcopal Diocese of Oregon. Now in its 52nd year, WTH looks forward to a continuing partnership with the diocese and with churches endeavoring to enrich their ministries to the working poor. Future plans may include becoming an accredited center for clinical pastoral education. This diocesan budget item is intended to help in the development of partnership of WTH with the diocese.

#### Line 74: Companion Diocese – \$1,000

The Diocese of Oregon and the Diocese of Cuernavaca have developed a "Companion Relationship." Bishop Enrique and Bishop Michael have realized that budding relationship through joint visits and participation by Oregon Episcopalians in a two-week language class during in Cuernavaca. Further development of this relationship will bring benefit to both Diocese.

Line 75: Reserved – \$0

Line 76: Subtotal Gospel Justice - \$30,394

#### Line 77: Contingency/Operational Reserve – \$0

It is fiscally advisable to budget for a reserve each year in order to set money aside for unexpected declines in income, emergencies or emerging ministry needs which require immediate response. Due to the anticipated decline in revenue for 2021, all funds have been allocated to programs.

Line 78: Total Expenditures - \$1,739,354

<u>Line 79: Net Program Budget Surplus/(Deficit)</u> – \$0

#### Summary of Ministry

The Board of Trustees is charged with acting in the capacity of directors for Diocesan business. We are privileged assist congregations with grnts and loans to support their various ministries throught out the Diocese. We also support other activities of the Diocese in allocating resources as needed, both financial and as technical support. Canon Eligren continues to assist us in walking with congregations needing a plan to move forward.

#### 2020 highlights

Since January 2020 the Board was able to fund several emergency grants and others for repair and sustainable improvements for congregations. One such grant was to St. Michael and All Angels Portland for solar panel installations. The congregation leverage out grant and grants from other to make this dream a reality. We hope th their experience can become a pilot project for other congregations. #### Commission to End Racism



#### Summary of Ministry

The Commission to End Racism was reimagined and relaunched in May, 2020. The Commission's working mission statement is: We show forth Christ by facing the truths and legacies of racism and repenting of the sins of racism through reconciliation and healing.

#### 2020 highlights

With the support of the Diocese of Oregon and Bishop Hanley, the Commission sponsored and launched a diocesan-wide Sacred Ground group for priests, hosted a two diocesan-wide forums on responding to racist violence, a conversation about race and racism for the 2020 Clergy Conference, including a separate break out for clergy of color prior to the clergy conference, all facilitated by the Rev. Shaneequa Brokenleg, TEC staff officer for Racial Reconcilation. The CTER recruited a leadership team and new members, lay and clergy from around the diocese, and the majority of the CTER members identify as people of color. Additionally, the CTER applied for and received an EBOF grant for \$25,000 per year over the next three years to support our diocese in the Gospel work of anti-racism.

#### 2021 plans that differ from 2020

The CTER is in the process of identifying and planning ways we can best support the people of the Diocese of Oregon. We are supporting the Diocesan resolution calling for the establishment of a Truth and Reconciliation Committee and anticipate working closely with that group. Additionally, the newly formed Commission will continue to discern the ways we can best support the diocese through education and anti-racism training, resource sharing, facilitation training, advocacy, and local support.

#### Summary of Ministry

Dismantling Racism Trainings is required for all people serving in positions of leadership in our Diocese (General Convention Resolution). This includes clergy, Diocesan Council, Standing Commission, Board of Trustees, Diocesan Staff, leaders of key diocesan committees and commissions, Convocation Deans and Presidents, and Deputies to General Convention. Our ministry provides the training.

#### 2020 highlights

During 2020 we finished revising the training to bring it in line with the Episcopal Church focus on Becoming Beloved Community and Dismantling Racism. We offered one in person training on February 28 at Trinity Episcopal Cathedral. This was the first time the revised training was offered. Evaluations and feedback about the training were positive.

The training group had hoped to offer a training in Southern Oregon, but COVID-19 prevents that. We are working on offering a training via Zoom. Rather than an all day training it will need to be divided into four, two-hour sessions.

#### 2021 plans that differ from 2020

We will coordinate the training with the work of the newly formed Commission to End Racism, and we will offer two trainings via Zoom.

#### Summary of Ministry

This foundation financially supports "the creation and development of healthy diocesan institutions, vital congregations, and organizations in the diocese". We do this through a quarterly grant cycle, with deadlines for grant applications of February 28, May 31, August 31 and November 30, and grant reviews within six weeks of deadlines.

#### 2020 highlights

We have given small monetary grants to our seminarians, postulants, and a retiree, and funded nine grants. These grants were awarded for congregations to enhance thier electronic technology, support additional staff needs, fund a dditional needs at Hospitality Village at Resurrection, Eugene and to support the College of Bishops and the Episcop al Church Foundation. The amount granted so far this year is \$122,202.00. When the Covid19 coronavirus became a pandemic in March, we also put together a new granting vehicle specifically for congregations and other diocesan organizations to apply for COVID-19 Emergency Grant funds to help sustain them during this unpresidented time. To date we have granted funds to 36 congregations and 6 affiliated organizations in the total amount of \$335,457.00.

#### 2021 plans that differ from 2020

We will end the granting vehicle for COVID-19 Emergency grants when the pandemic comes to an end, hopefully by spring or summer of 2021. Otherwise, we will continue to live out our mission statment by partnering financially with diocesan institutions, congregations and affiliated organizations in thier efforts to create and develop faithful commun ities and organizations full of joyful leaders, formed in Christ offering sacramental hospitality with a clear mission in the world.

# EPISCOPAL DIOCESE OF OREGON

#### **Education for Ministry**

#### Summary of Ministry

Education for Ministry (EfM) is a unique four-year distance learning certificate program in theological education based upon small-group study and practice. EfM helps the faithful encounter the breadth and depth of the Christian tradition and bring it into conversation with their experiences of the world as they study, worship, and engage in theological reflection together. The Diocese of Oregon has had Education for Ministry groups since the early 1980's.

#### 2020 highlights

At the beginning of 2020, sixty-one people were engaged in Education for Ministry seminars in six parishes: St. Paul's, Salem; Good Samaritan, Corvallis; St. John's, Bandon; St. Bartholomew's, Beaverton; St. David's, Portland; and Trinity, Bend (not really in our Diocese, but included as we provide administrative services). At the end of 2020, Christ Church, Lake Oswego also had a group, bringing the total to seven parishes offering EfM and nearly 70 participants enrolled. EfM groups met in person prior to the beginning of the Covid virus, but quickly adapted to using Zoom as a medium. This was a challenge. Some members did not enjoy distance meetings, and a few dropped out, but in the fall, some others asked to join. In person Mentor training was also replaced by Zoom training.

#### 2021 plans that differ from 2020

Former mentors at St. Mary's Eugene, Trinity, Portland, and St. Paul's Oregon City are hoping to enroll enough people to start a group in the coming year.

The cost for a year of EfM is \$450 (textbooks and access to Oxford Biblical Studies online are included). However, since the Diocese sponsors the program, the cost per person is reduced to \$350.

Number of students 68; Cost with Diocese sponsorship 68\*350= \$23,800 Cost without Diocese sponsorship 68\*450=\$30,600

#### 2020 highlights

At the core of our ministry is the community that gathers on Thursday evenings for dinner, fellowship and worship. Each Thursday featured a different celebrant from the local community or wider diocese with their own story, style and insights. Local parishioners brought meals and shared their wisdom and insight into Christian living. In April we moved to weekly Zoom gatherings where we check-in, share highs and lows and prayer requests and join together for compline or Evening Prayer. This new format has allowed us to stay connected with alumni in Missouri and Florida and our dispersed residents.

A new, larger pantry location in a Lutheran church, and more support from the UO allowed us to feed more students.

#### 2021 plans that differ from 2020

For now, our in-person gatherings are limited to small group gatherings with the chaplain and student residents. We will continue to meet via Zoom for our weekly Evening Prayer or Compline, with the option of in-person Eucharist at St. Mary's. Our new budget is focused on formation, with monies allocated for student retreats, faith-building activities, and expenses for our chaplain to connect and build relationships with students. Monies are also set-aside for the ongoing maintenance needs and improvement projects of the student residence. As we look toward an uncertain future, our emphasis is on the safety and pastoral care of our student community. The ECM offers support during traumatic, turbulent times. In addition, we continue to address student food insecurity. Our focus is on welcoming, supporting, and helping students grow their faith and their connection to the Epsicopal Church.

# Fresh Start for Clergy & Congregations

#### Summary of Ministry

Fresh Start is a diocesan-led program for clergy in new positions and their congregations. Fresh Start's purpose is to support Episcopal clergy and their congregational leaders in navigating the critical period of transition in clergy leadership. At the same time the program promotes collegial relationships among clergy within a diocese.

#### 2020 highlights

Our Fresh Start program in 2020 has had up to 35 clergy in transitional ministry, with more expected to join as new calls are made in our diocese. We began the year in February with a retreat at the Alton L. Collins Retreat Center. The program materials enable learning in different methods from dialogue, workshop and critical incident sharing. We have learned from the participants in the group that the program has been very beneficial to integrating into their congregations and into the Diocese of Oregon. We moved to Zoom meetings in May. Topics explored in 2020 include Conflict Management; Leading Planned Change; Renegotiating Roles & Expectations; and Wellness: Self-Care in Transition.

#### 2021 plans that differ from 2020

Our plans include a retreat in February (if it is safe to do so) and monthly meetings in 2021. We will work with Bishop-elect Diana Akiyama to further develop this ministry in our diocese. We want to maintain the strength of supporting those who are starting new ministries in our diocese and the health of congregations welcoming new clergy leadership.

# Investment Committee Ministry Report for 2020 Diocesan Convention

#### Summary of Ministry

The Diocesan Investment Committee is a Standing Committee of the Board of Trustees, responsible for implementing and supervising three investment choices offered to the churches and missions of the Diocese of Oregon. We are governed by specific Investment Policy Statements and assisted by both Sellwood Consulting, our institutional investment consultant, and US Bank, custodian of the investment assets.

#### 2020 highlights

The Diocesan Investment Fund and the Socially Responsible Investment Fund both posted strong, double-digit recoveries (+15.2% for the DIF and +16.4% for the SRIF) during 2nd quarter 2020, following larger losses in March 2020 economic downturn. The recovery continued in the 3rd quarter of 2020 (+4.9% for the DIF and +7.2% for the SRIF). Year to date 2020, the DIF has returned -0.6% and the SRIF has returned +4.1%, net of fees.

Both Funds have weathered market volatility by remaining committed to a diversified asset allocation and the thoughtfully constructed, long-term investment approach employed by the Committee.

#### 2021 plans that differ from 2020

The Diocesan Investment Committee plans for 2021 include continuing to meet quarterly -- likely on a virtual basis -- to review investment results and investment managers. Additional ad hoc meetings and conference calls are scheduled as needed. At least annually, the DIC reports on the three investment strategies offered to Diocesan stakeholders. The report goes to both the Board of Trustees and Convention.

As part of that, we grant funds from the annual Pentecost offering to ministry projects around the diocese.

#### 2020 highlights

Because of COVID-19, the Pentecost Offering for 2020 was rolled over into the 2021 funds. We decided to focus updates from the grants awarded in 2019. Church of the Resurrection, who received a \$2000 grant in 2019, has continued to support the vital work of providing nutritious food, delivereing 8,565 lunches prepared by 265 volunte working 5,870 hours. St. Edward's has built four tiny cottages their grounds using their \$1500 grant. Christ Episcopal Church in St. Helens, in an ecumenical project, built two townhomes to provide stable housing for six people with their \$1500 grant. St. David of Wales in Portland used its \$1000 grant to support two of their parishioners experiencing homelessness. Grace Memorial in Portland is holding their \$2000 grant with plans to confer with the Council on how best to apply the funds, since their environmental study has been postponed.

One of our primary tasks is to attend to the Diocesan Personnel Manual, Clergy Manual, and to make recommendations on the SHU Chart. We also look at other ways to support the diocese, parishes, and employess in personnel matters.

#### 2020 highlights

As with so many things this year, the Personnel Committee's plans were disrupted by the pandemic. We primarily attended to matters presented by the crisis and dealt with time-sensitive matters like regular updates to the SHU chart. Turnover in membership necessitated finding new committee members. Several clergy members approached us with questions about taxes and we directed people to the helpful guide put together by the Church Pension Group to help address the complexities. Minor clarifications were made to the personnel manual and sample work agreements.

#### 2021 plans that differ from 2020

The Personnel Committee had planned in 2020 to explore in-depth the issues of pay equity and the use of the SHU chart. Sex and gender-based pay inequity is common across many fields, including the church. We wanted to research the specific situation in the Diocese of Oregon and then find ways to reduce the inequities that exist. Other than inflationary changes, the SHU chart and its methodology have not been reviewed and modified in decades. We wanted to research how parishes and clergy use the chart, identify strengths and weakness, and then look at possible modifications to make it a more effective tool. We hope to take up these matters in 2021. We always welcome questions and advice on personnel matters that we could help explore or clarify in order to support the employees, parishes, and institutions of the Diocese.

#### 2020 highlights

After convention last year we continued to make progress contacting congregagtions and giving presentation. Then came the shut-down and everything we had scheduled disappeared. We have now developed and have been offering Zoom and youtube videos, however many of the smaller and more far-flung communities have connectivity issues and cannot use these materials effectively if at all. We do expect to be able to reach more congregations in 2021 Because of our insistence on the scriptural and non-partisan stance, and listening to the anxieties and first-hand accounts we are offered, attendees participate very willingly and express gratitude for the wisdom of the delegates in passing the Resolution at convention 2017.

#### 2021 plans that differ from 2020

We will be exploring new ways to fund grants in light of the suspension of the basket raffle this year. Any and all ideas for raising \$10,000 to \$15,000 will be prayerfully considered.

So many of our congregations experience an increasingly shar need for those funds, even though they are exellent managers of time energy and money

That shortage of funds extends to the Task Force's work on universal health care, which involves a fair amount of travel throughout the diocese. However, a bigger need for the Task Force is for more people to join it.

## 2020 Prison Ministry Report



#### Summary of Ministry

In the era of Covid 19 the Diocese of Oregon's Prison Ministry Commission continues to serves the gospel justice through building bridges of love and respect restoring all people to the unity with God and each other. Our work with Oregon's criminal justice system, with inmates and their families, our organizational partners and one another has required us to creatively overcome significant barriers to our traditional operations.

#### 2020 highlights

The PMC 2019 Budget allocations to programs and strategic partners were completed by the end of January. In mid-March the Covid 19 virus hit closing all prisons and jails to non-essential persons. At the Lane County Jail we worked with Jail staff to plan and implement a highly effective Covid 19 safety plan although this meant that our chaplaincy work with inmates would be temporarly halted. As of this writing the Lane County Jail has performed 2, 816 tests with just 13 positive results. None of the 13 who tested positive are currently in custody and the jail has experienced no spread. Working closely with jail leadership staff, PMC has developed some alternative processes to in-person visitation including U.S. mail, scheduled phone visits and now utiliting the visitation area of the jail.

#### 2021 plans that differ from 2020

In 2021 PMC will continue to work with our partners in criminal justice services and advocacy to address the increased human needs of those impacted by necessary but severe restrictions that limit social and processional contacts to those in prisons and jails and their families. In the area of advocacy and education we will seek to support public calls for criminal justice reform by advocating for Restorative Justice as a philosophic and practice alternative to our current retributive justice system.

We have begun this work first by consulting with our partners in this work and public safety professionals about the most effective and efficient ways to make the systemic changes required to move toward a restorative justice system that builds the beloved community envisioned by biblical justice. We are plotting the map!

# SRI Stakeholder Advisory Committee Ministry Report for 2020 Diocesan Convention

#### Summary of Ministry

The SRI Stakeholder Advisory Committee (SAC) is a Committee supporting the Board of Trustees and its Investment Committee with respect to the Socially Responsible Investment Fund (SRIF). The SAC is responsible for communications regarding the SRIF, research on socially responsible investing, and coordination of the triennial dot-voting process.

#### 2020 highlights

The SRIF has amassed a strong track record since its inception in August 2016, returning 9.6% annualized net of fees as of September 30, 2020, and outpacing a traditional 60% equity/40% bond portfolio by nearly 2% over the same time period.

In January 2020, Consistent with UN Sustainable Development Goals (SDGs), the SRIF made a 0.7% allocation to a community impact investment note offered by Craft3. Craft3 has a 25+ year history of micro-lending to underserved businesses, nonprofits and individuals in our local community. SRIF managers have provided impact and stewardship reporting for 2020, highlighting exciting examples of reduced carbon emissions, gender equality improvements, and community development efforts.

#### 2021 plans that differ from 2020

The SRIF will continue to focus on top SRI priorities identified via a polling process of Convention delegates. These priorities include positive investments related to climate & clean technology, human rights, community development and diversity & equal opportunity, and divestment efforts related to pollution & toxics, human rights, executive & exploitative pay, and animal cruelty.

An updated dot-voting process is scheduled for 2021 and a renewed focus on social justice is already underway. SRIF investment managers have led the charge in promoting greater diversity on corporate boards, advancing pay equity, and addressing inequities in the workplace. Advocacy efforts have included shareholder resolutions, public policy engagements, proxy voting, education efforts, and financial contributions.

#### Summary of Ministry

Standing Committee, is defined by canon as the Bishop's Council of Advice. In addition to offering support and advice to the bishop, the committee also makes recommendations regarding those in the ordination process and gives consent, or not, to the election of new bishops. In addition, since May of 2019 the Standing Committee has been overseeing the Search and Transition process.

#### 2020 highlights

This past year Standing Committee consented to 6 episcopal elections, and recommended 4 individuals for ordination to the transitional diaconate, 3 to the vocational diaconate and 4 to the priesthood. We reviewed and approved the new Vision/Mission Statement. We presented the slate of candidates in March. The Petition Process was announced and concluded without any applications. The Transition Committee planned, replanned and excuted the Walkabout and Electing Convention remotely during COVID-19. The first ever such process in TEC.

#### 2021 plans that differ from 2020

The recommended salary for our Bishop in 2021 represents an 8% increase from 2020; and a 30% increase from the projections first used when we began the Search process for our new Bishop. This increase resulted from a review of the Episcopal salary scale provided by Church Pension Fund. This change brings the Diocese in line with with the national church and is long overdue. In 2021 we look forward to working closely with Bishop-Elect Akiyama as she begins her Episcopal ministry among us.

William Temple House is a place of healing and hope through services supporting the whole person—mind, body, and spirit. With the help of a large group of active volunteers, William Temple House offers mental health counseling, a food pantry, spiritual care, and a community thrift store that helps fund our programs. We support 6,000+ individuals each year, many of whom access our services regularly throughout the year to stay stable and healthy.

#### 2020 highlights

In 2020, we completed a strategic planning process, including client needs surveys and eight focus groups with clients, interns, donors, and other stakeholders. We continue our diversity, equity, inclusion (DEI) initiative to deepen our agency's commitment to these values, better serve our clients, and inform our future. While our strategic plan timeline shifted to a short-term crisis plan due to COVID-19, we continue to strengthen our programs and operations. Through this process, we have confirmed the importance and priority of the food pantry and mental health counseling to our community during COVID-19 and beyond, and are reimagining spiritual care that deepens existing connections within the diocese, and honors individual and varying spiritual practices and beliefs among our community members.

#### 2021 plans that differ from 2020

As a result of the COVID-19 pandemic, we have seen an increase in client visits and an influx of new clients who are newly unemployed, unsheltered, or both. In 2021 we will continue to provide essential community services. Our counseling program now uses a telehealth model with phone and computer conferencing, enabling our counselors to meet with clients more often. We plan to offer telehealth and in-person options when it is safe to do so. Our food pantry space has been expanded and new safety protocols are in place to keep clients, staff and volunteers safe.
